

End User Licence Agreement (EULA)

The term "Font Software" or our typefaces refers to coded and encrypted software designed to generate typeface designs when utilized with compatible hardware and software. This »Font Software« End User License Agreement ("Agreement") is entered into between the purchaser ("Licensee") and Michael Leonhartsberger, hereinafter referred to as "Licensor." By purchasing, downloading, installing, or otherwise using the »Font Software« provided by Licensor, Licensee agrees to be bound by the terms and conditions of this Agreement.

1. Grant of License:

Licensor grants Licensee a non-exclusive, non-transferable license to use the »Font Software« for the intended purpose of generating typeface designs when used with the appropriate hardware and software.

2. Ownership:

The rights to the designs generated by the »Font Software« remain the property of Licensor. Licensee acknowledges that the purchase of the »Font Software« does not confer ownership of the font but grants a license for its use.

3. License Types:

The »Font Software« is licensed for a specific number of users (desktop license) or page views per month (web license), as specified in the purchase. Licensee may refer to our shop for available options. For additional licensing needs, Licensee must contact Licensor.

4. Distribution and Sublicensing:

The »Font Software« or documentation may not be sublicensed, sold, leased, rented, lent, or given away to another person or entity. Unauthorized distribution of the »Font Software« is strictly prohibited.

5. Delivery and Installation:

Upon completing the purchase and receiving payment via PayPal, or bank account Licensee will receive an individual order automatically. Any issues should be reported to Licensor for resolution.

6. Usage Restrictions:

Licensee agrees not to distribute, resell, or sublicense the »Font Software« to a third party. Embedding »Font Software« into electronic documents is allowed for printing purposes and use on private computer networks. Such documents may be viewed and printed (but not edited) by the recipients.

Other restricted use examples are:

- Using software capable of creating and/or exporting font files, such as Glyphs, RoboFont, FontLab, FontForge, etc., to open the supplied font files is strictly prohibited. If there is a desire to customize the provided fonts, individuals are invited to reach out to Michael Leonhartsberger to explore the possibility of commissioning a bespoke typeface.
- Convert the files to web fonts on third-partyplatforms

- Resell or sub-license any asset
- Resell any modification of the assets on its own
- Make the assets public or share the asset in any way

7. Compatibility:

The »Font Software« is optimized for MAC OS X and Windows. Licensor does not guarantee full functionality on other operating systems.

8. File Formats:

Desktop files are provided in the OpenType (otf) and TrueType (tt) format, compatible with both Windows and MAC. Web files are available in woff, woff2 formats.

9. Modifications:

Licensee may not modify the fonts or its characters without contacting Licensor for approval as a bespoke project.

10. Updates and Modifications:

Licensor reserves the right to update this License Agreement without prior notice. Licensee is responsible for regularly reviewing the Agreement. Licensor continuously tests and updates fonts, and Licensee is entitled to free updates of the originally purchased typeface.

11. Warranty and Support:

Licensor does not warrant against defects, installation, export problems, or other irregular issues. Licensee is encouraged to contact Licensor for technical assistance. Licensor is not responsible for damage to hardware, software, or loss of income resulting from »Font Software« use.

12. Returns and Exchanges:

No returns or exchanges are offered unless the »Font Software« is defective. In case of defects, Licensor will provide technical assistance upon contacting support.

13. Miscellaneous:

Licensee accepts all risks associated with the installation of »Font Software«. Licensor is not liable for any damages caused. The competent court at the registered office of Michael Leonhartsberger shall have local jurisdiction to decide on all disputes with consumers arising from this contract.

14. Updates:

This Agreement may be updated by Licensor at any time. Licensee is advised to check the Agreement regularly for changes.

By purchasing, downloading, or using the »Font Software«, Licensee acknowledges having read and understood this Agreement and agrees to be bound by its terms.
